


Dear Sir,

- I, Shanu Bhagwandas Mata, Proprietor of Shanu Mata and Associates, Company Secretaries, have been appointed by the Board of Directors of RichiRich Inventures Limited ("Company") as Scrutinizer for the purpose of:
  - Scrutinizing the remote e-voting process in terms of the provisions of Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended (Rules) and

- The Company has completed the dispatch of Notice of Annual General Meeting along with the Annual Report of the Company as on June 01<sup>st</sup>, 2023 to its members whose names appeared on the register of Members/ List of beneficiaries.
- Advertisement was published by the Company in English in Business Standard, dated June 02<sup>nd</sup>, 2023 and in Marathi in Mumbai Mitra, dated June 02<sup>nd</sup>, 2023.
- The Voting rights were reckoned as on Friday, June 23rd, 2023, being the cut-off date for the purpose of deciding the entitlements of members at the remote e-voting and voting at the Meeting.
- The Company has availed services of National Securities Depository Limited (NSDL)
  as the agency for providing the remote e-voting platform.

The remote e-voting period was open for three days which commenced on June 27<sup>th</sup>, 2023 at 09:00 A.M. and concluded on June 29<sup>th</sup>, 2023 at 5:00 P.M. on https://www.evoting.nsdl.com Members who were present at the AGM and had not cast their votes electronically were provided an opportunity to cast their votes at the end of the meeting through e-voting again for 15 Minutes.
- The remote e-voting results on the National Securities Depository Limited (NSDL) E-voting platform were unblocked and downloaded on Friday, June 30th, 2023 in the presence of two witnesses who are not in the employment of the Company.
- 7. On scrutiny, we report that 30 Shareholders were present in the meeting through video conferencing.
