- 6. Figures for the Half Year ended 30.09.2021 and corresponding Half Year ended 30.09.2020 are the balancing figures in respect of full financial year and the unaudited published year to date figures upto the fourth quarter of the respective financial year.
- 7. During the year, the Company has identified an amount of Rs.3,47,318/- to be written off, as the same was give as adavnce to certain parties, which is now not recoverable. However, during the half year, the Company has written off Rs.48,000/- only. No provision is made in the books of accounts for the balance amount which is to be written off of Rs.2,99,318/-.
- 8. The Company is looking for new business opportunities and till the time the Company starts any new busniess, the surplus funds which were lying idle with the Company, the Company has invested in Mutual fund/granted loans and advances to certain parties on temporary basis to earn, rather than keeping them idle. The Company is of the view, that, since the funds are given as loan and advances only on temporary basis and since it is not the primary business activity of the Company, the Company has accordingly prepared its financials as per Indian Accouting Standards (Ind AS). The Company is not Non Banking Financial Institution (NBFC) and accordingly no registration is required with RBI and the Company is also not intending to carry out any activity as NBFC.
